Plaintiff alleges the following causes of action against Defendants:

**I. INTRODUCTION**

1. Plaintiff brings this action in an effort to stop Defendants and others from copying and distributing to others unauthorized copies of the Plaintiff’s copyrighted motion picture through the BitTorrent file sharing protocol. Defendants’ infringements allow them and others to unlawfully obtain and distribute unauthorized copyrighted works that the Plaintiff expended significant resources to create. Each time a Defendant unlawfully distributes an unauthorized copy of the Plaintiff’s copyrighted motion picture to others over the Internet, each person who copies that motion picture can then distribute that unlawful copy to others without any significant degradation in sound and picture quality. Thus, a Defendant’s distribution of even a part of an unlawful copy of a motion picture can further the nearly instantaneous worldwide distribution of

1 that single copy to an unlimited number of people. Further, Defendants acts of distributing  
2 Plaintiff's motion picture support, maintain and further a for-profit exploitation of the works of  
3 Plaintiff and others. The Plaintiff now seeks redress for this rampant infringement of its exclusive  
4 rights.

## 5 II. JURISDICTION AND VENUE

6 2. This is a civil action seeking damages and injunctive relief for copyright  
7 infringement under the copyright laws of the United States (17 U.S.C. § 101 et seq.).

8 3. This Court has jurisdiction under 17 U.S.C. § 101 et seq.; 28 U.S.C. § 1331 (federal  
9 question); and 28 U.S.C. § 1338(a) (copyright).

10 4. Venue in this District is proper under 28 U.S.C. § 1391(b) and/or  
11 28 U.S.C. §1400(a). Although the true identity of each Defendant is unknown to Plaintiff at this  
12 time, on information and belief each Defendant may be found in this District and/or a substantial  
13 part of the acts of infringement complained of herein occurred in this District. On information and  
14 belief, personal jurisdiction in this District is proper because each Defendant, without consent or  
15 permission of Plaintiff as exclusive rights owner, distributed and offered to distribute over the  
16 Internet copyrighted works for which Plaintiff has exclusive rights.

## 17 III. PARTIES

### 18 A. PLAINTIFF LHF PRODUCTIONS, INC. AND ITS COPYRIGHT

19 5. Plaintiff LHF Productions, Inc. is a developer and producer of the motion picture  
20 *London Has Fallen* for theatrical exhibition, home entertainment and other forms of distribution.  
21 The motion picture was first published March 4, 2016.

22 6. *London Has Fallen* is protected by the Copyright Act in motion picture Registration  
23 No. PA 1-982-831, effective March 14, 2016. (Exhibit A)

24 7. Under the Copyright Act, Plaintiff is the proprietor of all right, title and interest in  
25 *London Has Fallen*, including the exclusive rights to reproduce and distribute to the public as well  
26 as the right to sue for past infringement.

1           8.       *London Has Fallen* contains wholly original material that is copyrightable subject  
2 matter under the laws of the United States. It is an action thriller directed by Babak Najafi and  
3 stars Gerald Butler, Morgan Freeman and Aaron Eckhart, among others. It is easily discernible as  
4 a professional work as it was created using professional performers, directors, cinematographers,  
5 lighting technicians, set designers and editors and with professional-grade cameras, lighting and  
6 editing equipment. It has significant value and has been created, produced and lawfully distributed  
7 at considerable expense. *London Has Fallen* is currently offered for sale in commerce, playing in  
8 theaters and available for rental and/or purchase from Amazon, iTunes and Netflix, among others.

9           9.       Defendants have notice of Plaintiff's rights through general publication and  
10 advertising and more specifically as identified in the content of the motion picture, advertising  
11 associated with the motion picture, and all packaging and copies, each of which bore a proper  
12 copyright notice.

13       **B.       DEFENDANTS**

14           10.       Upon information and belief, each Defendant copied and distributed Plaintiff's  
15 copyrighted motion picture *London Has Fallen*. The true names of Defendants are unknown to  
16 Plaintiff at this time. Each Defendant is known to Plaintiff only by the Internet Protocol ("IP")  
17 address assigned by an Internet Service Provider ("ISP") and the date and at the time at which the  
18 infringing activity of each Defendant was observed, as explained in detail below. Through  
19 geolocation, the IP address used by each Defendant has been traced to the Western District of  
20 Washington. Plaintiff believes that information obtained in discovery will lead to the identification  
21 of each Defendant's true name and location and permit Plaintiff to amend the complaint to state  
22 the same.

23           11.       In addition, each IP address has also been observed and associated with significant  
24 infringing activity and associated with the exchange of other titles on peer-to-peer networks. The  
25 volume, titles and persistent observed activity associated with each Defendant's IP address  
26 indicates that each Defendant is not a transitory or occasional guest, but is either the primary

1 subscriber of the IP address or someone who resides with the subscriber and/or is an authorized  
2 user of the IP address. The volume of the activity associated with each Defendant's IP address  
3 further indicates that anyone using or observing activity on the IP address would likely be aware  
4 of the conduct of Defendant. Also, the volume and titles of the activity associated with each  
5 Defendant's IP address indicates that each Defendant is not a child, but an adult, often with mature  
6 distinct tastes.

#### 7 **IV. PEER-TO-PEER NETWORKS AND THE BITTORRENT PROTOCOL**

8 12. Defendants are each a participant in a peer-to-peer ("P2P") network using the  
9 BitTorrent protocol. The BitTorrent protocol makes even small computers with low bandwidth  
10 capable of participating in large data transfers across a P2P network. To begin an exchange, the  
11 initial file-provider intentionally elects to share a file with a torrent network. This initial file is  
12 called a seed. Other users ("peers") connect to the network and connect to the seed file to  
13 download. As yet additional peers request the same file each additional user becomes a part of the  
14 network from where the file can be downloaded. However, unlike a traditional peer-to-peer  
15 network, each new file downloader is receiving a different piece of the data from users who have  
16 already downloaded the file that together comprises the whole. This piecemeal system with  
17 multiple pieces of data coming from peer members is usually referred to as a "swarm." The effect  
18 of this technology makes every downloader also an uploader of the illegally transferred file(s).  
19 This means that every "node" or peer user who has a copy of the infringing copyrighted material  
20 on a torrent network can also be a source of download, and thus distributor for that infringing file.

21 13. This distributed nature of BitTorrent leads to a rapid viral spreading of a file  
22 throughout peer users. As more peers join the swarm, the likelihood of a successful download  
23 increases. Essentially, because of the nature of the swarm downloads as described above, every  
24 infringer is sharing copyrighted material with other infringers.

25 14. Defendants actions are part of a common design, intention and purpose to hide  
26 behind the apparent anonymity provided by the Internet and the BitTorrent technology to

1 download pieces of the copyrighted motion picture in a manner that, but for the investigative  
2 technology used by Plaintiff, would be untraceable, leaving the Plaintiff without the ability to  
3 enforce its copyright rights. By participating in the “swarm” to download Plaintiff’s copyright  
4 motion picture, the Defendants agreed with one another to use the Internet and BitTorrent  
5 technology to engage in violation of federal statute to accomplish and unlawful objective.

6 **V. COMPUTER FORENSIC IDENTIFICATION OF BITTORRENT INFRINGEMENT**

7 15. Plaintiff has identified each Defendant by the IP address assigned by the ISP used  
8 by each Defendant and the date and at the time at which the infringing activity of each Defendant  
9 was observed. This is accomplished using forensic software to collect, identify and record the IP  
10 addresses in use by those people that employ the BitTorrent protocol to share, copy, reproduce and  
11 distribute copyrighted works.

12 16. More specifically, forensic software is used to scan peer-to-peer networks for the  
13 presence of infringing transactions with respect to a particular audiovisual work. Any digital copy  
14 of an audiovisual work may be uniquely identified by a unique, coded, string of characters called  
15 a “hash checksum.” The hash checksum is a string of alphanumeric characters generated by a  
16 mathematical algorithm known as US Secure Hash Algorithm 1 or “SHA-1.” This software  
17 facilitates the identification of computers that are used to transmit a copy or a part of a copy of a  
18 digital media file identified by a particular hash value by their IP address at a particular date and  
19 time. To overcome concerns with spoofing or the like, a direct TCP connection is made to each  
20 defendant’s computer. Additional software using geolocation functionality is then used to confirm  
21 the geographical location of the computer used in the infringement. Though an IP address alone  
22 does not reveal the name or contact information of the account holder, in this case the Doe  
23 Defendant, it does reveal the likely general location of the Defendant. IP addresses are distributed  
24 to ISPs by public, nonprofit organizations called Regional Internet Registries. These registries  
25 assign blocks of IP addresses to ISPs by geographic region. In the United States, these blocks are  
26 assigned and tracked by the American Registry of Internet Numbers. Master tables correlating the

4 IP addresses with local regions are maintained by these organizations in a publicly available and  
5 searchable format. An IP address' geographic location can be further narrowed by cross-  
6 referencing this information with secondary sources such as data contributed to commercial  
7 databases by ISPs.

8 17. The end result are evidence logs of infringing transactions and the IP addresses of  
9 the users responsible for copying and distributing the audiovisual work, here *London Has Fallen*.  
10 The IP addresses, hash value, dates and times, ISP and geolocation contained in Exhibit B correctly  
11 reflect the subscribers using the IP addresses and that they were all part of a "swarm" of users that  
12 were reproducing, distributing, displaying or performing the copyrighted work.<sup>1</sup>

### 13 VI. JOINDER

14 18. Each Defendant is alleged to have committed violations of 17 U.S.C. § 101 *et. seq.*  
15 within the same series of transactions or occurrences (e.g. downloading and distribution of the  
16 same copyrighted motion picture owned by Plaintiff) and by using the same means (BitTorrent  
17 network). The infringed work was included in one file related to the torrent file; in other words,  
18 all of the infringements alleged in this lawsuit arise from the exact same unique copy of Plaintiff's  
19 movie as evidenced by the cryptographic hash value. The Defendants are all part of the exact same  
20 "swarm." Defendants' acts occurred in the same series of transactions because each Defendant  
21 downloaded and/or distributed, or offered to distribute *London Has Fallen* to other infringers on  
22 the network, including the Doe Defendants and/or other network users, who in turn downloaded  
23 and/or distributed the motion picture. The temporal proximity of the observed acts of each  
24 Defendant, together with the known propensity of BitTorrent participants to actively exchange

26 <sup>1</sup> In logs kept in the ordinary course of business, ISPs keep track of the IP addresses assigned to their subscribers. Once provided with an IP address, plus the date and time of the detected and documented infringing activity, ISPs can use their subscriber logs to identify the subscriber with more specificity. Only the ISP to whom a particular IP address has been assigned for use by its subscribers can correlate that IP address to a particular subscriber. From time to time, a subscriber of Internet services may be assigned different IP addresses from their ISP. Thus, to correlate a subscriber with an IP address, the ISP also needs to know when the IP address was being used. Unfortunately, many ISPs only retain for a very limited amount of time the information necessary to correlate an IP address to a particular subscriber, making early discovery important.

1 files continuously for hours and even days, makes it possible that Defendants either directly  
2 exchanged the motion picture with each other, or did so through intermediaries and each shared in  
3 the distribution of the motion picture to others. Therefore, Defendants each conspired with other  
4 infringers on the BitTorrent network to copy and/or distribute *London Has Fallen*, either in the  
5 same transaction or occurrence or a series of transactions or occurrences.

6 19. To use BitTorrent, a user intentionally downloads a program that they then install  
7 on their computer called a “client.” The BitTorrent client is the user’s interface during the  
8 downloading/uploading process. The client may be free, supported by advertising, offer upgrades  
9 or add on services for a fee, or a combination of several options. Users then intentionally visit a  
10 “torrent site” or network site to find media or content available for download, often using a  
11 standard web browser. A torrent site is often advertising revenue or subscription supported index  
12 of media or content being made available by other users on the network and maintains a listing of  
13 movies and television programs among other protected content. A user then uses the torrent site to  
14 connect with other users and exchange or “share” content though the BitTorrent protocol often  
15 with many users at the same time.

16 20. Internet piracy, and in particular BitTorrent piracy, though known as peer-to-peer  
17 file sharing, is often a for-profit business as many software clients, torrent sites and networks  
18 generate millions of dollars in revenue through sales and advertising. To increase the value of the  
19 advertising and sometimes subscription access sold by torrent sites, many torrent sites work to  
20 expand the pool of available titles and speed of downloads through increasing the number of  
21 member peers and thus the desirability of their clients and networks. To accomplish this, they  
22 reward participants who contribute by giving them faster download speeds, greater access, or other  
23 benefits.

24 21. A significant element of the BitTorrent economic model is that those who  
25 participate and download movies not only share and upload movies with others, but participants  
26 are often rewarded through various means based on the volume and availability of content

1 participants in turn provide the network. In sum, there is a feedback incentive for participants as  
2 they obtain not only the benefit of their pirated copy of a movie, but they obtain other benefits by  
3 increasing the availability of pirated content to others. As such there are a growing number of users  
4 that participate in peer-to-peer networks and receive personal gain or compensation in that the  
5 networks they use reward those who provide large numbers of files for upload to others.

6 22. The use of BitTorrent does more than cause harm through the theft of intellectual  
7 property. The BitTorrent distribution of pirated files is a model of business that profits from theft  
8 through sales and advertising and a system of rewards and compensation to the participants, each  
9 of whom contribute to and further the enterprise. Each Defendant is a participant in the BitTorrent  
10 distribution of pirated files and the substantially similar conduct of each Defendant furthered a  
11 model of business that profits from theft of intellectual property including Plaintiff's motion  
12 picture.

13 23. Accordingly, pursuant to Fed.R.Civ.P. 20(a)(2) each of the Defendants is therefore  
14 properly joined at least because: (a) the infringement complained of herein by each of the  
15 Defendants was part of a series of transactions involving an identical copy of Plaintiff's  
16 copyrighted work; (b) the conduct of each Defendant jointly and collectively supported and  
17 advanced an economic business model of profiting from the piracy of Plaintiff's copyrighted work;  
18 (c) there are common questions of law and fact; and (c) each Defendant knowingly and actively  
19 participated in a conspiracy to perform an illegal act and/or injure Plaintiff through use of the  
20 BitTorrent protocol to infringe Plaintiff's copyrighted work.

21 24. Permissive joinder in the instant case is to permit a more efficient management of  
22 Plaintiff's claims against the several Defendants and to reduce the costs to Plaintiff and Defendants  
23 and to reduce the costs and burdens on the Court. Notice is provided, that on being specifically  
24 identified and on request from an identified Defendant, Plaintiff agrees to sever any Defendant  
25 that claims prejudice in being joined in this matter and to proceed against each such Defendant  
26 individually.

**VII. CAUSE OF ACTION—COPYRIGHT INFRINGEMENT**

25. Plaintiff realleges the substance of the prior paragraphs.

26. Plaintiff owns the exclusive rights to the commercially released motion picture *London Has Fallen*, which has significant value and has been acquired, produced and created at considerable expense.

27. At all relevant times Plaintiff has been the holder of the pertinent exclusive rights infringed by Defendants to the copyrighted motion picture *London Has Fallen*. The motion picture is the subject of a valid application for and/or Certificate of Copyright Registration.

28. Plaintiff is informed and believes that each Defendant, without the permission or consent of Plaintiff, has used, and continues to use, an online media distribution system to wrongfully misappropriate, reproduce and distribute to the public, including by making available for distribution to others, *London Has Fallen*. On information and belief, each Defendant participated in a swarm and/or reproduced and/or distributed the same seed file of *London Has Fallen* in digital form either directly with each other. Plaintiff has identified each Defendant by the IP address assigned to that Defendant by his or her ISP and the date and at the time at which the infringing activity of each Defendant was observed.

29. In addition, or in the alternative, Defendants obtained Internet access through an ISP and permitted, facilitated and materially contributed to the extensive use of the Internet through his ISP for infringing Plaintiff's exclusive rights under The Copyright Act by others. Defendants, with knowledge of the infringing conduct, failed to reasonably secure, police and protect the use of his Internet service against use for improper purposes such as piracy, including the downloading and sharing of Plaintiff's motion picture by others. Defendants had the right and ability to supervise and control the activity constituting the infringement.

30. In doing so, each Defendant has directly, indirectly and/or contributorily violated Plaintiff's exclusive rights of at least reproduction, preparation derivative works and distribution.

1 Each Defendant's actions constitute infringement of Plaintiff's exclusive rights protected under  
2 17 U.S.C. § 101 et seq.

3 31. *London Has Fallen* contains a copyright notice advising the viewer that the motion  
4 picture is protected by the copyright laws. Each of the Defendants' actions with respect to  
5 copyright infringement and other acts described herein were made with full knowledge of  
6 Plaintiff's ownership of the copyrights in the motion picture.

7 32. The conduct of each Defendant is causing and, unless enjoined and restrained by  
8 this Court, will continue to cause the Plaintiff great and irreparable injury that cannot fully be  
9 compensated or measured in money. The Plaintiff has no adequate remedy at law. Pursuant to  
10 17 U.S.C. §§ 502 and 503, the Plaintiff is entitled to injunctive relief prohibiting each Defendant  
11 from further infringing the Plaintiff's copyright and ordering that each Defendant destroy all copies  
12 of the copyrighted motion picture made in violation of the Plaintiff's copyrights.

13 33. By reason of the foregoing acts, if such remedy is elected at trial, Plaintiff is entitled  
14 to statutory damages from Defendants pursuant to 17 USC §504, *et seq.* Alternatively, at Plaintiff's  
15 election, Plaintiff is entitled to its actual damages incurred as a result of Defendants' acts of  
16 infringement plus any profits of Defendants attributable to the infringements.

17 34. The foregoing acts of infringement have been willful, intentional, and in disregard  
18 of and with indifference to the rights of Plaintiff.

19 35. As a result of each Defendant's infringement of Plaintiff's exclusive rights under  
20 copyright, Plaintiff is entitled to its attorneys' fees and costs pursuant to 17 U.S.C. § 505.

#### 21 **VIII. PRAYER FOR RELIEF**

22 **WHEREFORE**, Plaintiff prays for judgment against each Defendant as follows:

- 23 A. Pursuant to 17 U.S.C. §502, an order preliminarily and permanently enjoining each  
24 Defendant from directly or indirectly infringing Plaintiff's rights in *London Has*  
25 *Fallen* and any motion picture, whether now in existence or later created, that is  
26 owned or controlled by Plaintiff, including without limitation by using the Internet  
to reproduce or copy, distribute or otherwise make available for distribution to the

1 public Plaintiff's motion pictures, except pursuant to a lawful license or with the  
2 express authority of Plaintiff.

- 3 B. Pursuant to 17 U.S.C. § 503, an order that each Defendant destroy all copies of  
4 Plaintiff's motion pictures that Defendant has downloaded onto any computer hard  
5 drive or server without Plaintiff's authorization and shall destroy all copies of those  
6 motion pictures transferred onto any physical medium or device in each  
7 Defendant's possession, custody, or control.
- 8 C. An order that each Defendant file with this Court and serve on Plaintiff, within  
9 30 days of service of this order, a report in writing under oath setting forth in detail  
10 the manner and form in which Defendants have complied with the terms of the  
11 ordered relief.
- 12 D. Pursuant to 17 U.S.C. § 504 or other applicable provision, for actual or statutory  
13 damages, at the election of Plaintiff, and a finding of willful infringement.
- 14 E. Pursuant to 17 U.S.C. § 505, for Plaintiff's reasonable attorneys' fees and costs.
- 15 F. For such other and further relief as the Court deems proper.
